Read:	Telangana Excise (Grant of license of selling by shop and conditions of license) Rules, 2012 (GO MS No. 391 Revenue (Ex.II) Department dt: 18.6.2012) Notice of drawal of lots for Grant of licence to sell IMFL & FL by Shop under Rule 5 of Telangana Excise (Grant of license of selling by shop and conditions of license) Rules, 2012. Whereas, the right of selling by shop is to be granted for the licence period from 01-12-2023 to 30-11.2025 and whereas the Director of Prohibition & Excise Telangana fixed the number of A4 shops to be licensed in the areas/localities vide CR No. 3060/2023/CPE/TS/F1, dt: 02-08-2023. The drawl of lots is done by the District Collector, Nirmal. But due to low response to the following (04) A4 shops situated at Nirmal & Bhainsa Stations, was postponed vide Cr.No. 3060/2017/CPE/TS/F1-3 dt. 19-08-2023. The Director of Proh.& Excise, T.S. Hyderabad has instructed to issue Supplementary notification vide Cr.No. 3060/2023/CPE/TS/F1-3, dt: 22-08-2023.

Hon'ble Supreme Court India in Arun Kumar Agarwal vs. Union of India and other in WP.No. 69/2012 order dated 9th May 2013 in paragraph 39 held that "*Matters relating to economic issues, have always an element of trail and error, so long as a trail and error are bona fide and with best intentions, such decisions cannot be questioned as arbitrary, capricious or illegal.*"

Further, Hon'ble High Court (DB) of Andhra Pradesh in P. Subhash vs. the State of AP in PIL No. 223 and batch, order dated 18th July 2012 held that "*In matters relating to economic issues, the Government has while taking a decision, right to trail and error*" as long as both trail and error are bona fide and within the limits of authority."

After a detailed examination of the reports and with a view to ensure fair trade practices by providing an opportunity to probable applicants, without effecting the right of existing applicant(s), and to protect government revenue, it is decided to give additional time to accept fresh applications for the (4) shops vide Director of Proh & Excise,TS.Hyderabad Cr.No. 3060/2017/CPE/TS/F1-3, dt: 22-08-2023.

I, G. Srinivas Reddy, District Prohibition & Excise Officer Nirmal District/Unit, in exercise of the powers vested in me under Rule 5 and 24 of Telangana Excise (Grant of license of selling by shop and conditions of license) Rules, 2012, issue the following notification for information
